

**REDDING RANCHERIA STILLWATER POW WOW  
VENDOR BOOTH RENTAL CONTRACT**

This contract is entered into as of \_\_\_\_\_, 2009, between the Stillwater Pow-Wow Committee (herein after called Rentor) and \_\_\_\_\_ (herein after called the Rentee).

1. **Subject Matter** Rentor herein offers each 15' x 15' booth space for the above period or periods. Rentor promises to promote these events in a reasonable manner to draw patrons.
2. **Responsibilities** Rentee herein is responsible for all water, power and fixtures as necessary to display his/her wares. Rentee is also responsible for all Permits and Insurance necessary to conduct his business in a public place. Rentee promises to leave the Booth Area CLEAN of all debris. Rentee promises to conduct his business in compliance with all Federal, State and Local Laws and Regulations. **Note:** Food or Beverage Rentees are not allowed to sell duplicate items that the Pow-Wow or other booths are selling. Please check with the Vendor Person to verify that you do not duplicate, they will let you know what is and is not allowed.
3. **Terms of Contract** Rentee hereby selects the following date(s) for displaying his/her wares:

4. **Compensation** Rentee here by pays Rentor \$650.00 for Food Booth, \$450.00 for Beverage Booth, and \$225.00 for Retail Booth per space for the term of this Contract. Compensation is to be paid in full.
5. **Special Provisions** Each event goes on regardless of the weather and Rentor is not responsible for lost revenues or refunds because of the weather.
6. **Indemnification** Rentee agrees to indemnify and hold Rentor harmless (including its officers and members) against any and all claims, liabilities, litigation, costs and expenses incident thereto, including reasonable attorney fees, which Rentee may hereafter incur as part of this conduction business in this event.
7. **Force Majeure** If, because of Force Majeure, either party is unable to carry out any of its obligation, except the payment of money, under this Contract then that party must give immediate notice to the other party of that condition.

*The term "Force Majeure" as used herein shall mean any unforeseen causes beyond the control and without the fault or negligence of the party claiming such event.*
